| •     | The park closes at 10 p.m. and you must vacate the park by that time.<br>Vehicles, including bicycles, <b>are not permitted in the park</b> .<br>Grassy areas must not be used for pathways or for other purposes which may in-<br>jure or destroy the turf.   |  |  |  |  |  |
| •     | Trees, shrubs, hedges and flowers must not be cut, broken or injured in any way.<br>Buildings, fences, fountains, statuary, benches or notices must not be damaged or<br>defaced in any way.   |  |  |  |  |  |
| • • • | Papers, rubbish or any refuse must be disposed of in the receptacles provided.<br>Birds, squirrels, rabbits or any wild creature are not to be disturbed in any way.<br>Firearms are not permitted within the parks.<br>Fires are not permitted except in the outside cooking grills for food preparation. |  |  |  |  |  |

- Dispensing of handbills, cards or advertisements of any nature is prohibited in the parks.
- Alcohol is allowed by permit only. Contact the Borough Office at 724-266-4820.
- Gambling, drunkenness, disorderly or indecent conduct, profane or offensive language are prohibited in the parks.
- Games, contests and sports are permitted only in areas designated for such use, and in no case shall such use be permitted in area where lawns or planting may be injured, or where such games or contests may interfere with park regulations.
- It shall be unlawful for any person to enter or loiter in the park after daylight hours.
- Dogs and other pets are not permitted in the parks.

## Splash Pad - Use at your own risk - NO lifeguard on duty.

## The SPLASH PAD will be CLOSED during inclement weather.

- All children 10 years and under must be under the direct supervision of an adult.
- Children that are not toilet trained must wear a swim diaper and a bathing suit.
- Street shoes are not allowed on the splash pad. Water shoes are recommended.
- Have children use the restroom before going into the splash pad.
- - NO Food or drinks are permitted.
- NO Tobacco and alcohol products
- - NO Running or hazardous play
- NO Glass or other hazardous objects
- NO Pets
- - NO Bikes, skates, rollerblades or skateboards
- NO Open sores or wounds
- - NO Abusive language
- - NO Persons under the influence of alcohol or illegal drugs
- NO Cut-off shorts
- NO Persons who are ill
- - NO Diapers, swim diapers permitted
- NO Climbing on the water features
