Question on the Motion by Ms. Lee inquiring if the food bank is being considered a senior program? Council discussed that most enrolled participates are seniors. Ms. Lee confirmed that this expense was already paid and Council is just categorizing it and then moving forward Council needs to make decision on it. Mr. Robb added that if Borough Council wants to authorize tax payors funds on such expenditures, then Borough Council needs to authorize the expenditure.

Mr. Robb provided the following information, the Borough Code provides that Borough Council can appropriate from Borough funds money for the handling, storage and distribution of surplus foods obtained through a governmental agency. Also, the code allows expenditures for the benefits of seniors.

Question on the Motion by Ms. Carroll, we will have a plan moving forward so the mayor can continue to do theses things. Mayor Ford confirmed that the volunteers will not continue to receive lunch and each time a lunch is planned Council will need to approve it first and planning ahead, the mayor announced wanting to host two picnics, two dinners and Christmas Party, located at the high rise and open to all seniors. Ms. Lee stated that the high-rise houses more than just seniors and when helping our seniors it should be more accessible to more seniors. Mayor Ford added that relocating the senior events from the high rise to the community room would be costly for the transportation. Ms. Lee confirmed that other senior programs can be considered, it doesn't have to be food and labor.
