Mr. Conlon advised that the Borough Code is very specific on what council can appropriate money for and the list is in section 1202, subsection 42, specifically states that borough council can appropriate money for the handling, storage and distribution of surplus foods, not for gift cards and advised that it's council decision to vote on it or not

Mr. Awad mentioned past practice

Mr. Nanni believes that means what you can spend money on, that's not all you can spend money on Mr. Conlon stated, no it's pretty specific that it has to fall into one of those categories and the category that comes closest is subsection 42, that states the handling, storage and distribution of surplus foods and advised that having paid borough employees at the food bank is allowed and that gift cards are not. Council discussed other options briefly.

Mr. James stated that donations were received in the past from a resident to cover the cost of the gift cards for the food bank

Tony Rosenberger, Chapman Properties, 100 Leetsdale Industrial Drive, provided a project timeline for the newly constructed building, located at 1201 Brickworks Drive and requested the release of a temporary occupancy permit.

Dominic Napolitano, 15 Valley Lane, expressed concern with the motion to purchase gift cards. Mr. Conlon confirmed that he provided the statutory authority that limits the use of Borough funds for the handling, storage and distribution of surplus foods. Mr. Napolitano suggested that according to subsection 41, (section 1202 subsection 41 of the Borough Code), council may appropriate in any year out of the general funds for the observance of holidays or centennial or other anniversaries, and council agreed.
